NSPS Fall Business Meeting continued...

Here than are a list of initiatives and observations from our fall meetings:

- The ALTA/NSPS Standards have been approved by both organizations and we will have new standards that take effect on February 23, 2016.
- NSPS will prepare a position statement on U.A.S. (unmanned aircraft systems) regulations and operations. We've also signed on with other mapping organizations in crafting a letter to urge the F.A.A. to codify the government's regulations for operating this technology in a more urgent manner.
- The young surveyors group had a productive meeting and started to think about bylaws, sub committees and addressing tasks that many have offered up for them to consider. Approximately 11 of them attended the Board of Directors meeting on Friday.
- We intend to broaden the awareness of the Young Surveyors and our National Society at educational institutions across the country by inviting a student to attend our meetings as our guest and write a short review that will be shared with all surveying programs. The program will be administered by the Young Surveyors and funded through NSPS Board of Director donations. We intend to have a student in attendance at the 2017 spring meeting.
- Our President Jon Warren & President-Elect Tony Cavell have each made a significant effort to re-align our committees and offer specific charges for these committees to work on. PLEASE consider having your constituents sign on to the email distribution lists for a committee by contacting the chair of that committee. It's a great way to be involved without the commitment of attending our meetings.
- The Director from Alaska requested support regarding the setting of monuments by the BLM when creating Townships that would be further subdivided and sold by the State of Alaska. As you might have guessed, the number of monuments being set has been drastically reduced. Our Government Affairs Committee will review and comment on the matter
- Certified Survey Technicians (CSTs) at all levels and existing membership can now have their annual certification fee waived by maintaining a membership in NSPS.
- The NSPS Joint Government Affairs Committee shoulders a great deal of responsibility in representing surveyors across the nation on Capitol Hill. Please review their report for the many tasks and/or accomplishments they have had over the last 6 months. Mr. Pat Smith, Chair of the Committee, requested direction from the BoD on the following matters:
 - NSPS will provide a position statement on the PHMSA (Pipeline Hazardous Materials Safety Agency) Proposed Rule which contains a number of references to surveying and mapping – and provide a standardized position to our state affiliates
 - NSPS will provide a position statement to the House Financial Services Committee which is considering modifications to the National Flood Insurance Program (NFIP), either to implement an improved working process or privatize the effort
 - Support the addition of the Small Business Administration (SBA) to Federal Acquisition Regulation (FAR) Council – given that many small businesses are effected by FAR regulations.
- The NSPS 100% Membership Program has been very successful. We currently have 47 states participating, just under 17,000 members, and continue to offer our help to those still considering the program.
- We continue to collaborate with NGS and participate in quarterly meetings on various initiatives
- We are recognized by ABET as the professional organization for evaluating 31 Surveying Programs across the country.
- Our CST program that has been a monumental success and run by several individuals for many years, and even decades. Their succession plans require them to look for individuals who are interested in serving on the CST Board and upholding the fine standard which has been set. Please consider this opportunity and contact President Warren if you are interested in this appointment.

Common Research Mistakes Surveyors Make (Seniority of Title)

I am often involved in litigation involving surveying services and research mistakes. (I must also admit that in excess of forty years of practice, I have made my share of mistakes performing record research.) There are five common mistakes often made by surveyors when researching the records. The first article will explain the common mistake made by surveyors when determining senior title.

Many surveyors are under the misunderstanding that once a person conveys property, they cannot subsequently convey good title in the same property to another person. This is never true. In fact, there is not a single state recording act that would place senior title with the first grantee unless the grantee took immediate steps to record the deed or take possession of the property.

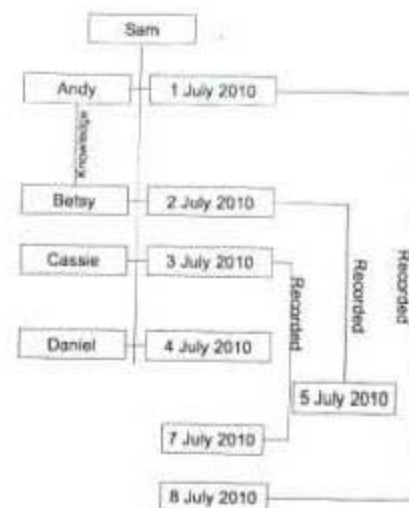
The recording acts in all states fall into one of three general categories of statute: 1) Race, 2) Notice, and 3) Race-Notice. The general definition of each category is the following:

Race — The first person to record their deed has senior title regardless of the sequence the conveyances were made or the knowledge a grantee had of an earlier conveyance.

Notice — The last conveyance made where the grantee did not have notice of an earlier conveyance has senior title

Race-Notice — The first person to record their deed who was conveyed the property without notice of an earlier conveyance has senior title.

Consider the following example: Sam conveys a lot to Andy on 1 July 2010. A short time later, Andy tells Betsy that he purchased the lot from Sam. Betsy goes to Sam and offers to buy the same lot that Sam sold to Andy. Even after Sam explains to Betsy that he has already conveyed the lot to Andy, Betsy insists of paying money to Sam in order to obtain a deed to the lot. Sam, with marginal ethics, goes for the money and conveys the same lot to Betsy on 2 July 2010 that was previously sold to Andy. Sam now realizes he can make a considerable profit if he keeps conveying the same lot to other individuals without knowledge of an earlier conveyance of the lot. Consequently, Sam conveys the same lot to Cassie on 3 July 2010. On 4 July, Sam conveys the same lot to Daniel. On 5 July, Betsy records her deed. (Thereby providing “the world” constructive notice of a conveyance of the lot from Sam.) On 7 July, Cassie records her deed. On 8 July Andy records his deed. Daniel never records his deed.



Common Research Mistakes continued...

Even though Andy was the first conveyance from Sam, he does NOT have senior title under any of the recording acts. Under the “race” category of recording act, Betsy has senior title. Betsy was the first to record a deed to the lot. Under the “notice” category of recording act, Daniel has senior title. Daniel was the last person to be conveyed the lot without notice of an earlier conveyance. In fact, Daniel will have senior title under a notice category of recording act even though Daniel never records his deed. Under a “race-notice” category of recording act, Cassie has senior title. Cassie was the first person to record a deed from Sam that was delivered to her without notice of an earlier conveyance.

As can be seen from this example, without knowledge of the category of a state’s recording statute, surveyors will often terminate their record research prematurely or will mistakenly determine senior title resides with the wrong person in a situation such as an overlap.

A surveyor should take the time and determine what category of recording statute is effective in their state. At least two states have more than one category of recording act in effect.

ALTA Land Title Survey Requirements

The American Land Title Association (ALTA) was founded in 1907 and is the national trade association and voice of the abstract and title insurance industry whose members search, review and insure land titles to protect home buyers and mortgage lenders who invest in real estate. ALTA and the American Congress on Surveying and Mapping (ACSM), now the National Society of Professional Surveyors (NSPS) established the first set of Standard Detail Requirements for Survey drawings in 1964. These instructions were established to nationally standardize the requirements for survey drawings that were to be used for ALTA loans. Updates to the requirements often occur every four-to-six years. The last recent revision took place in 2011 in conjunction with NSPS. Notable changes implemented included:

- Requirement to reference a title report on the Certificate of Survey
- Requirement to include Standard ALTA Certification
- Greater attention to offsite easements and servitudes
- Changes to the Table A items for Optional Survey Responsibilities and Specifications.

An ongoing revision has been completed and will become effective February 2016. Gary Kent, chair of the NSPS committee on the ALTA Standards has agreed to come to Connecticut on April 19, 2016, and present a full day seminar on these new changes.

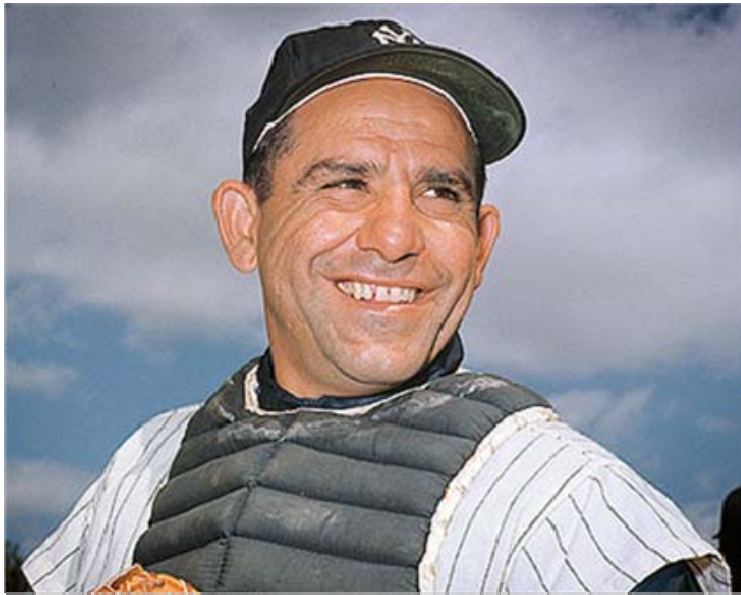

I Lied to Yogi, and that is the Simple Truth

When Yogi passed, my friend Alonzo posted some photos of and quips about Yogi. I had been thinking about Yogi and I shared this story with him. My wife suggested I share it with everyone or at least the everyone that I know.

The first baseball number I wore was 8. I played one form or another of organized ball into my sixties. I did not always wear 8, but when I finally finished playing ball 2 or 3 years ago I was wearing 8. Clearly 8 is the perfect number, whenever Yogi slid or dove for a ball it was infinity.

I don't remember a great deal prior to 1960, for that matter I don't remember a great deal after 1960. I do remember

a day in 1957 or 1958. Baseball was my first love, a love that has endured. My dad would bring us to a game or two a year. Sitting in the upper decks, by the foul poles, it did not matter. Being at the Yankee Stadium was a gift. Writing this is like seeing that perfect field for the first time all over again.

This particular day my dad had gotten front row tickets directly behind home plate. Even though it meant we would have no chance to catch a ball, I was thrilled to be sitting so close to Yogi. The umpire and Yogi turned around and came over to have a look for themselves. Having no more luck than the ball boy, they looked at each other puzzled.
