Connecticut Association of Land Surveyors Annual MAP DESIGN COMPETITION

November 4, 2016 - Contest Rules

1. Map Design Contest is open to ALL CALS Members. Preparer/drafter AND certifying surveyor must both be CALS Members.
2. ALL entries must be received at the CALS office no later than Wednesday, October 26, 2016.
3. ALL entries must bear an original date no earlier than October 31, 2015, the date of last year's annual meeting. Revision dates to map bearing original date earlier than October 31, 2015, are not acceptable.
4. ALL entries must be prepared using: The Regulations of State agencies, sections 20-300b-1 through 20-300b-20. (This includes Presentation Drawings.) "The specific survey type or types MUST be stated in the title. "Property/Boundary Survey" or "Limited Property/Boundary Survey" are NOT survey types. "Resurvey", "Dependent Resurvey", "Original Survey" or "First Survey" also are NOT survey types but Boundary Determination Categories. Any map not meeting these few basic requirements will not be judged or put on display."
5. Entries shall consist of unmounted blue or black line prints/plots being standard size (24" x 36", 18" x 24" or 12" x 18") except for Presentation Drawings (which shall be no larger than 36" x 48" and may be in color) Boundary and Construction Stake-out sketches may be smaller than standard size at 8.5"x11" or 11"x17".
6. Entries may be either hand drawn or produced by mechanical means.
7. All entries must be accompanied by an official entry form, and should not be folded.
8. Entries are limited to two (2) per category. Firms are allowed to enter plans in the same category by different drafters.
9. Decisions of the judges are final. Any ties in the judges scores will be broken by the committee chairperson's vote.
10. All maps meeting the minimum eligibility requirements (see 4 above) will be mounted and displayed and the winners will be announced at the annual meeting.
11. It shall be the responsibility of the "Best in Competition" winner to forward their entry to the National Competition if they so choose. CALS will pay the registration fee. All maps must be signed and sealed.

JUDGING STANDARDS

1. Conformance with "Standards"

*Conformance with the "Standards for Surveys and Maps in the State of Connecticut", adopted by CALS on September 26, 1996 (Sections 20-300b-1 through 20-300b-20 of the Regulations of Connecticut State Agencies) **no others accepted.*** "For example, the specific survey type or types MUST be stated in the title.

"Property/Boundary Survey" or "Limited Property/Boundary Survey" are NOT survey types. "Resurvey", "Dependent Resurvey", "Original Survey" or "First Survey" also are NOT survey types but Boundary Determination Categories."

2. Content

A. *Clear interpretation of what map is intended to depict.*

B. *Technical aspects - Accuracy levels, attention to detail, monumentation quality, etc.*

3. Aesthetic Quality

A. *Neatness*

B. *Layout*

C. *Proportional scale to plan size*

D. *Artistic influence and originality (line weighing strategy, font/text style variations, symbology, etc.)*

4. Degree of Difficulty



Alfred E. Schindler Recognized at Wall of Honor Ceremony

A public ceremony was held on September 10 for Ellington's Wall of Honor newest inductee, Alfred E. Schindler. Friends, family members and business associates attended the afternoon event, each personally thanking Schindler prior to, and after, a brief speech by First Selectman Lori Spielman. The town's Honor Guard was also present for the occasion.

Of Schindler's many contributions to the town of Ellington, his most commended project was the publication of the Ellington Proprietor's Map in 1985, a joint effort with town historian Dorothy Cohen. The map, which involved six years of research, shows how the land within the town of Ellington was originally divided among the first land owners and is the basis for all subsequent land transfers. In addition to his numerous contributions to the town of Ellington, Schindler shared his knowledge and talent at the state and national levels in the surveying profession and has served as a mentor to countless up-and-coming surveyors throughout his career.



Interesting Facts About Autumn

Autumnal Equinox - On the first day of autumn, the sun is aligned with the center of the earth, between the north and south of the planet. As a result, the number of daylight hours and darkness hours are equal. This day — which falls on either Sept. 22 or 23 — is known as autumnal equinox.



Green Leaves Begin to Disappear - During autumn, days are short. Consequently, the trees don't get enough sunlight and the process of photosynthesis stops. The green chlorophyll starts disappearing from the leaves and colors like red, orange and purple become prominent, which earlier weren't visible due to the presence of green chlorophyll.

Migration of Birds - With the onset of autumn, many species of birds begin to migrate to warmer climate for sufficient food supply. This migration of millions of birds is considered to be one of the most prominent event in the calendar of the natural world. Ireland is considered to be an important center for Arctic and European migratory birds.

Food Shortage - For squirrels, autumn is the season for storing food. They collect and bury nuts throughout the season for winter, and the nuts they don't use turn into trees.



Harvest Moon - As many crops ripen during late summer and early autumn, farmers have to spend long hours in the fields to harvest the crops. During this time, the light of the full moon — which is called the Harvest Moon — is quite important for the farmers as it allows them to work after sundown. The Harvest Moon happens before the autumn equinox.

No Autumn for the Equator - Unlike the Polar Regions, the regions closest to the equator do not experience autumn. These areas more or less experience the same climate throughout the year.

Autumn Babies Live Longer - According to a study in the Journal of Aging Research, a baby born in autumn has a higher chance of living 100 years compared to those born during other seasons. The study found that 30 percent of the centenarians in the U.S. were born between 1880 and 1895 in autumn.

Greek Mythology - Per Greek mythology, when Persephone — the daughter of Zeus and the harvest goddess Demeter — was abducted by Hades, the god of the underworld, Demeter destroyed all the crops on Earth in distress. This marked the start of autumn and the ground remained cold until her daughter returned in spring.



It's Time to Hibernate - Many creatures — including bears, groundhogs and bees — start preparing for the winter hibernation as the fall rolls around. They will start looking for warm and dry places to sleep through the cold months.

Interesting Facts About Autumn



Northern Lights - NASA claims that autumn is the best time to view northern lights, which is also known as aurora season, as the frequency of geomagnetic storms double up during the season.

Autumn in the Southern Hemisphere - While the Northern Hemisphere experiences autumn from September through November, countries in the Southern Hemisphere go through autumn from March through May.

Gaining Weight - Usually people tend to crave comfort food on cold nights and so they end up eating fattier foods in autumn — resulting in seasonal weight gain. Also, as less sunlight is available during the season, it leads to shortage of vitamin D, which in turn reduces fat breakdown and boosts fat storage.

Autumnal Depression - Called Seasonal Affective Disorder (SAD), this depression impacts around 4 to 5 percent of the female population during autumn. Interestingly, men have a lower chance of having this issue.


